\*Because we have "two-yearly" programmes, we calculate the approximate % of the eligible population who are sent an invitation by dividing the number of invitations sent in the previous two years by the population of eligible women in the current year.

The main reason for not being able to send invitations to all the eligible women is the fact that we do not yet posses a complete register of the population. Our "population register", in the current mode of operation, does not capture all the resident population. Moreover, many addresses in it are not up to date.

"Number of mammographies" means the number of mammographies in the context of the Programme. Private sector mammographies are not included.

#### **General notes:**

From the invitations sent, a large number of women in the program chose to make mammogram at another center than the skilled one.

#### For Nicosia:

Number of invitations sent: 2010 we had the software for the first time which sent double invitations and also sent back invitations to addresses that returned (incomplete address).

Number of women refered for further assessment: Many women that their results are normal still they ask for additional mammography (mammography per year).

#### For Larnaca:

The program started in 2004. There was no specialized center at the time and the procedure was taking place in other centers. From 2012 the operation of a specialized center has begun.

Number of letters returned: There is no staff for the recording of returns.

# For Paphos:

The program started in 2004.

Number of letters returned: The reason that the invatations returned were not recorded it is not known.

#### For Limassol:

The program started in 2007. There was no specialized center at the time and the procedure was taking place at the old Limassol General Hospital. From 2012 the operation of a specialized center has begun. Number of letters returned: Returns were not recording.

## For Famagusta:

The program started in 2006.

Number of invitations sent: In 2007 no invitations were sent because all invitations sent in 2006. Same occurred in 2013 where no invitations were sent because all invitations sent in 2012. Number of letters returned: There is not enough staff for the recording of returns.
